

The Terms and Conditions were last updated on 8 October 2024

1. Introduction

These Terms and conditions apply to this website and to the transactions related to our products and services. You may be bound by additional contracts related to your relationship with us or any products or services that you receive from us. If any provisions of the additional contracts conflict with any provisions of these Terms, the provisions of these additional contracts will control and prevail.

2. Binding

By registering with, accessing, or otherwise using this website, you hereby agree to be bound by these Terms and conditions set forth below. The mere use of this website implies the knowledge and acceptance of these Terms and conditions. In some particular cases, we can also ask you to explicitly agree.

3. Intellectual property

6. Responsible use

By visiting our website, you agree to use it only for the purposes intended and as permitted by these Terms, any additional contracts with us, and applicable laws, regulations, and generally accepted online practices and industry guidelines. 7. Registration

You may register for an account with our website. During this process, you may be required to choose a password. 8. Refund and Return policy

8.1 Right of withdrawal

You have the right to withdraw from this contract within 14 days without giving any reason.

The withdrawal period will expire after 14 days from the day on which you acquire, or a third-party other than the carrier and indicated by you acquires, physical possession of the goods.

To exercise the right of withdrawal, you must inform us of your decision to withdraw from this contract by an unequivocal statement (for example a letter sent by post, fax, or email). Our contact details can be found below. You may use the attached model [withdrawal form](#), but it is not obligatory.

If you use this option, we will communicate to you an acknowledgement of receipt of such a withdrawal on a durable medium (for example by email) without delay.

To meet the withdrawal deadline, it is sufficient for you to send your communication concerning your exercise of the right of withdrawal before the withdrawal period has expired.

8.2 Effects of withdrawal

If you withdraw from this contract, we shall reimburse you all payments received from you, including the costs of delivery (with the exception of the supplementary costs resulting from your choice of a type of delivery other than the least expensive type of standard delivery offered by us), without undue delay and in any event not later than 14 days from the day on which we are informed about your decision to withdraw from this contract. We will carry out such reimbursement using the same means of payment as you used for the initial transaction unless you have expressly agreed otherwise; in any event, you will not incur any fees as a result of such reimbursement.

We will collect the goods.

We will bear the cost of returning / collecting the goods.

You are only liable for any diminished value of the goods resulting from the handling other than what is necessary to establish the nature, characteristics, and functioning of the goods.

Please note that there are some legal exceptions to the right to withdraw, and some items can therefore not be returned or exchanged. We will let you know if this applies in your particular case.

9. Idea submission

Do not submit any ideas, inventions, works of authorship, or other information that can be considered your own intellectual property that you would like to present to us unless we have first signed an agreement regarding the intellectual property or a non-disclosure agreement. If you disclose it to us absent such written agreement, you grant to us a worldwide, irrevocable, non-exclusive, royalty-free license to use, reproduce, store, adapt, publish, translate and distribute your content in any existing or future media.

10. Purchase terms

Free shipping on orders over 1,000 SEK at the E-shop.

Each item is listed with a price including VAT.

In the shopping cart, you can see the total price including all fees. Occasionally, some of the items you ordered may be out of stock and placed on backorder. This is due to errors in our inventory. If this occurs, we will send you an email within 1-3 days. Please contact us if you wish to cancel your backorder or if you have questions about delivery times, etc. If an item is backordered, this will delay your order, and if you choose to cancel it through our customer service, no fees will be charged.

You can now shop at your leisure and pay later or make partial payments.

A reminder fee will be charged for late payments. If you have purchased for under 60 SEK, a reminder fee of 29.00 SEK will be added, and if you have purchased for 60 SEK or more, a reminder fee of 60.00 SEK will be added.

10.1 Credit Check

At the time of purchase, a credit check is performed, which in some cases may involve a credit report (you will receive a copy of the credit report by mail). We do not inform banks or other lenders about a potential credit report.

10.2 Conversion to Flexible Installment Payments

Once you receive your invoice, you can apply to convert your invoice to flexible installment payments by paying a lower amount or by opting not to pay the full invoice amount. Flexible installment payments mean you pay at your own pace—with a minimum payment of at least 1/24 of the outstanding amount (but always at least 50 SEK per month). You can pay the entire amount in one go at any time.

Example: If you purchase for 10,000 SEK, the administrative fee is 29 SEK/month, and the variable annual interest rate is 19.9%. You would make monthly payments of 955 SEK for 12 months. The annual effective interest rate would then be 29.22%, and the total amount for your purchase of 10,000 SEK would be 11,458 SEK.

If the payment is less than the minimum amount, a late fee of 50 SEK will be added for amounts up to 200 SEK and 135 SEK for amounts over 200 SEK.

With the purchase of Crockett & Jones shoes with leather soles, free resoling (thin sole) is included. However, we recommend that the shoes be worn for a while before the sole is applied.

The customer is responsible for shipping to and from the store.
